- Green belt but has a 'Very Special Circumstances'
- Care home pre-app not yet undertaken
- Potential for c60-70 bed care home amongst trees





## Leamington Spa - Mixed Use

- Circa 6 acres in business park/ new residential
- Care home, supermarket, neighbourhood retail, football stadium, suitable infill resi.
- Planning submission in 2023
- Construction/ operational partners selected
